Product companies and businesses around the world are increasingly realizing the importance of providing proper web accessibility to the specially-abled.

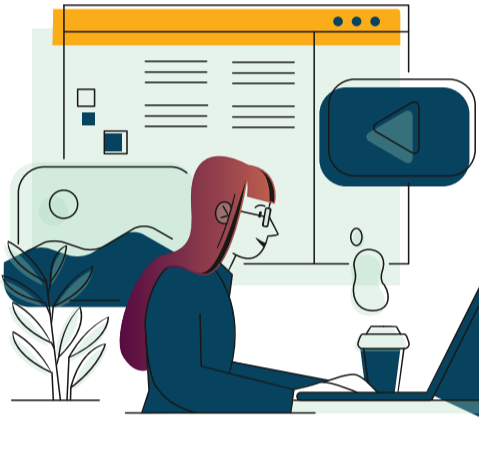


Many countries are coming up with regulations, which aim to provide mandatory and inclusive web accessibility and a better user experience for the differently-abled.

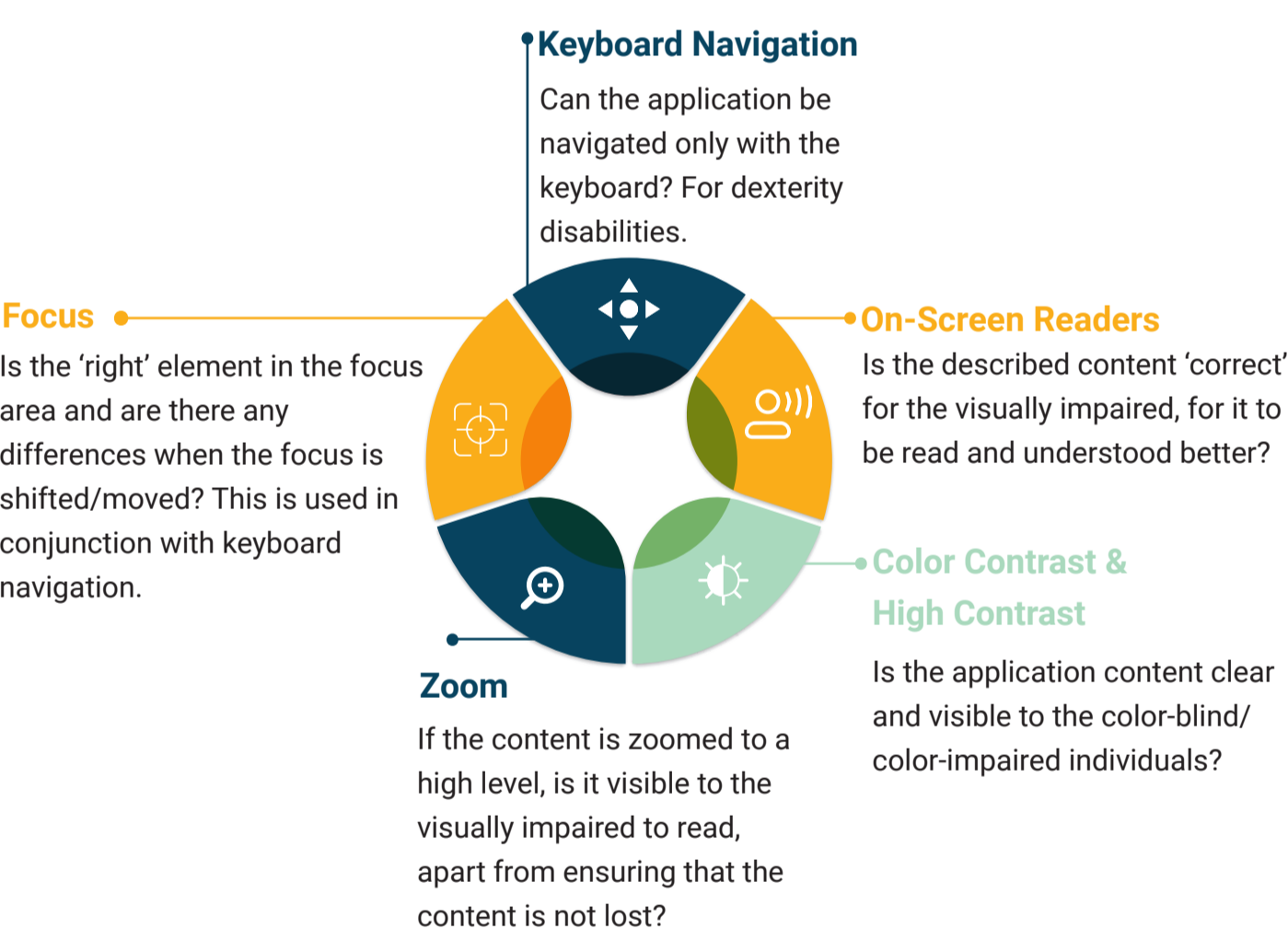

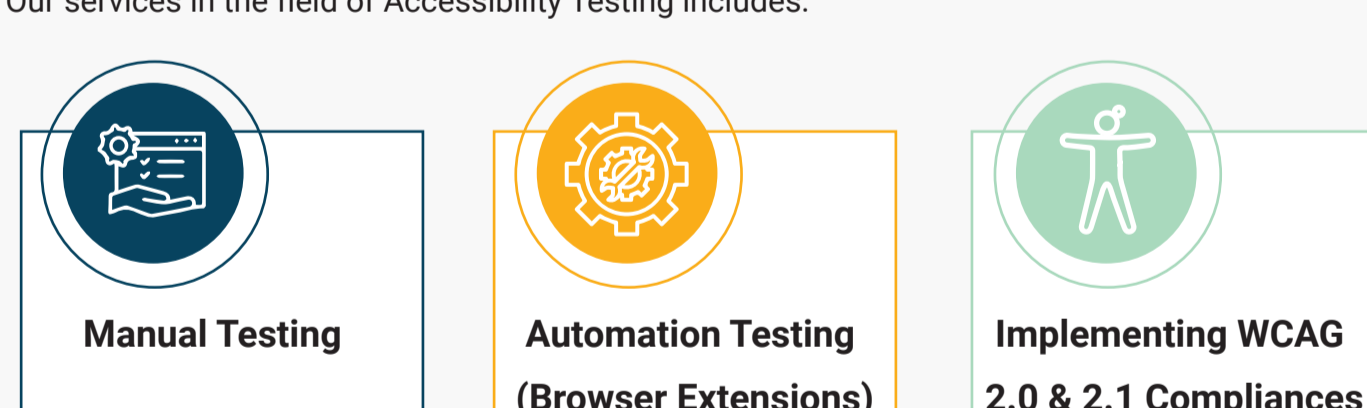
